When we look at the inflation rates of Suriname and the Netherlands and put them into historical context, we see unusual characteristics which will lead to an unhealthy economy in 2022.

Inflation Netherlands²

CBS reports that consumer goods and services were 6.2 percent more expensive in February than a year earlier. In January, inflation was 6.4 percent.

The context of the above figures should not be underestimated. The FED has now raised interest rates³ by 0.25%, and the ECB has not yet raised the interest rates. There are also no indications when the ECB will do this. The ECB has indicated that it will gradually reduce the purchase of government bonds. This means inflation is getting higher - the money printer was running over hours before the Covid pandemic, and with the pandemic even more - now that the war in Ukraine is going on, it will surely not stop. As a result, products in the Netherlands will become more expensive - gas and oil - and as a country that relies on imports from those regions, this will have disastrous consequences for Suriname.

The World Economic⁴ Outlook Update states that: "Global growth is expected to moderate from 5.9 in 2021 to 4.4 percent in 2022—half a percentage point lower for 2022 than in the October World Economic Outlook (WEO), largely reflecting forecast markdowns in the two largest economies. A revised assumption removing the Build Back Better fiscal policy package from the baseline, earlier withdrawal of monetary accommodation, and continued supply shortages produced a downward 1.2 percentage-points revision for the United States." The IMF also indicates that economic growth is not possible in 2022. With all the indicators we have, it is clear that monetary policy must be supported as a whole; it must be restructured. The IMF uses terminology like "Build Back Better," which should be examined closely. We must provide support by building a decentralized financial ecosystem with crypto that has backing. Because of the fractional banking and buying of government debt bonds, the economy has turned into a debt economy. There is no backing -no gold standard- behind the Dollar and Euro. The only solution for the fiat system is; crypto technology. The financial system and coin we introduce are called: "Redesigning our Monetary system" and will be perfected over time. ROM system and coins are not -yet- a substitute for money. ROM is not designed to eliminate the current fiat system because the current fiat currency is integrated within all layers of society. We are building a parallel monetary policy with a "project standard," which implicates that the ROM coin is multi-functional and backed by projects in the real economy. ROM works catalytically for the current fiat system and provides tools for growth, which benefits the real economy. We will elaborate on all the processes of ROM in this document.

Project standard


Usually, precious metals outperform stocks in a financial crisis and currency devaluation. The banking crisis, government deficits, and the accelerated depreciation of fiat currencies are causing many negative effects on the stock market. That's why gold is a safe haven in economically turbulent times.

But because of regulation by governments, this has become debatable in 2022. When you own gold that is not a specific hallmark, you may not be able to sell it in the future. And if the nutritional deficiencies persist during wars, you can't eat your gold.

ROM is multifunctional; it is an investment in a project, and the project simultaneously is the backing for the coin; this means no inflation. That is why ROM chooses to have projects as backing. With this method, the coin owner has control over his asset, and because the projects are selected primarily for turbulent times, it guarantees the value just like gold. Should war erupt and render all digital communication inoperative, gold would undoubtedly emerge as a viable refuge. Yet, the uninterrupted digital communication channels that remain intact provide blockchain technology with the foundational infrastructure necessary to position itself as 'digital gold', provided it is stewarded with the utmost ethical responsibility.

In design 1, the coin structure is shown schematically with its advantages. This workflow provides the transparency and trust needed to grow the coin's value.


Coin philosophy

The ROM coins provide the project's initial funding, or they will contribute to existing projects, which is the main reason for the long-term thinking of this investment. Due to the coin's value growth and the non-inflationary conditions of our financial ecosystem, it is also perfect for retirement savings. The asset is converted from crypto to fiat -when necessary- before making the investments. The ROI will partially go back to the ROM financial ecosystem. The intention is to finance scalable projects. The project standard of ROM guarantees that projects with a long-term perspective back the coin.

ROM intends to implement futuristic financial strategies with a multidisciplinary entrepreneurial approach. If we want a society that looks after the next generations' long-term benefits, we must adequately equip the entrepreneurs. For this reason alone, ROM intends to create a financial accountability structure that strategically serves all stakeholders; all transactions from money, knowledge, and project stages are visible to the public. The number one priority is transparency.

When looking at the current monetary policy, it is clear that it is an outdated, corrupt and inefficient model. It leaves room for money creation, thus sustaining the debt economy. From 1971, money was no longer linked by gold - the current fiat system has no gold standard- so the creation of paper money could continue without backing, with all adverse effects. One of those effects is inflation; eventually, this "effect" the middle-class pays. ROM is multi-functional because it is primarily linked with projects; the ROM crypto is the initial investment for the projects and, at the same time, a safe investment for your retirement. ROMs transparency methodology -which is unique in the blockchain world as in the conventional economy- creates trust, allowing investors to save the ROM coins right away because ROMs cryptocurrency could increase in value as the projects are completed.

ROM Ecosystem




Sustainability ROM ecosystem

There are two cashflow structures for ROMs raison d'être as design 3 shows. The projects open new areas like improved medical procedures and interventions, creating new jobs, giving opportunities to the least fortunate in society -blind and handicapped - and ensuring better working conditions. The activities mentioned above generate profit for the investors and ROM. One is the profits of selected projects, and the others are financial activities on the exchanges and blockchain products such as staking, farming, and creating new digital products which guarantee constant liquidity. The ROM coins increase in value, because of the investment in the conventional economy, with the purpose of society's well-being. The economic profits and well-being of society can be maintained simultaneously because of the accountability and transparency management style implemented in the ROM ecosystem.

Future Coin structure

All ten investment areas, together with the ROM ecosystem, will profit from the 100.000.000 ROM coins because of the multiple cash flows in the ecosystem. The ROM ecosystem allows diversifying your investment portfolio for a healthy balance in your assets and the importance of retirement savings. More coins can be made if they are backed with new projects. There will only be one coin at the start of the ROM ecosystem. The growth of the coin will ensure the solvency of each investment. 
Strategy for investors

The investment in ROM must not be made with a shorter-term perspective, as with banks in the fiat system; the same rules apply -temporarily- with the ROM infrastructure. If everyone chooses to trade in their coin immediately, the system collapses. The difference between ROM's infrastructure and fiat banks is; that when the ROM coin grows in value, it guarantees no inflation. Because of the fractional banking method, the bank can not assure the same stability and backing with their fiat money compared to the ROM coin. The ROM coins are invested in projects. For insights into all phases of the ROM projects and coins, the investors can access the website and BSC.scan at any time. The investments in ROM are two-dimensional. On the one hand, it is a direct financial injection in projects. And on the other hand, it is a long-term investment by saving the coin and HODL because the coin increases in value with no inflation, which assures a stable retirement asset. That's what it's all about for ROM; transparency. ROM USP is; that all investors, savers, and participants have insight into the progress of the ROM projects. The transparency method offered by ROM guarantees the liability of all participants. Other benefits:

- Invest in a country's development.
- Investing in entrepreneurs with great ideas but no capital.
- Relocate money; new investment opportunities.
- ROMs supervision and monitoring methodology ensure that the projects are completed within the set time frame; because all stakeholders are accountable.
- There is no inflation due to the policy that does not allow fractional banking and money printing.
- No corruption -not in policy formulation nor in implementation- because of our transparency method. And all participants have the same goal; "a completed project."

Parallel Economy

The multifunctional aspects are noticeable in practice and implementation. ROM is not only the ecosystem but functions as a coin itself and is also the company. We are registered at the chamber of commerce in a conventional way to execute the projects and cash flow registrations. However, we are also a DAO, so the people who have tokens/coins have the right to vote on which projects to execute or not; one of our methodologies of transparency and accountability.

Financial process

ROMs project investments are in fiat currency; after every coin purchase, the received coins must be converted to fiat money. The transaction route is straightforward -with some fees calculated in our tokenomics-. ROM coins/tokens can be purchased at pancakeswap. The investor will have to buy BNB, and with the BNB in the investor's wallet, the ROM coin can be immediately purchased. The ROM ecosystem receives the BNB, which goes into the liquidity pool. The BNB will be converted to a stable coin from the liquidity pool/ROM Metamask wallet and sold to the Binance exchange. When it is converted to Bitcoin on the Binance exchange, the bitcoins are then sent to the bank-Fiat system-. This "currency flow" will be reviewed every time, and the most lucrative and safest way will be implemented before converting into fiat capital and allocated to the ROM projects. The processes in the ROM ecosystem are managed by a consortium of an emeritus bank director, accountants, and lawyers to safeguard our core values. Transparency is guaranteed, and all the liquidity in the wallet will be visible on BSC.scan.

The procedures are transparent so that all participants can follow all transactions on the exchange.

Protocol

The DAO and CofC company are both named ROM. They are the same organization, with one entity operating in separate fields. One utilizes the mainstream business - conventional- which includes the day-to-day tasks of the projects. And the second works on the blockchain as a DAO -the future of finance-. Unifying their rules takes time and will be implemented in three phases -project phases page 8-; this guarantees the sustainability of the ROM ecosystem. The guidelines are essential; the protocols are coded in the smart contract (SC), and the mainstream business implements conventional contracts (CC). The protocols in the SC and CC will non-disruptively provide payments, securities, and trust. We need the CofC to communicate with financial institutions, governments, law firms, and accountant offices for accountability and expansion in the current economic system. While on the other hand, the DAO ensures a democratic decision-making process and a transparent financial allocation and reward system for motivation and engagement of the community.

ROM code

ROM's internal stakeholders will exhibit accountability and transparent management style and live up to the financial and project standard we highly uphold. The external compliance officer will evaluate Rom's code of conduct each year.

Before any investments in the ROM ecosystem, the external complaint and risk officers and an external lawyer will assess every project and product with the risk accounting standards with the "true and fair view" principle. The internal and external stakeholders must comply with the rules of ethical corporate management. If they violate the ROM code based on transparency and accountability, they are liable to the company for damages.

ROM is the bridge for allocating conventional and crypto investments, ensuring project completions.

Conventional Investors

These investors invest in the company on the regular market and receive a 7% return on a minimum investment of Euro 700,000.00

Crypto Investors

This category grows with the coin, buys the coin, receives airdrops as a reward, and sees the value of the coin increase. Furthermore, with an investment of 10% project cap, the investor can receive a minimum of 7% APY.

Difference between these two types of investors:

The crypto investor has ROM coins equal to the DAO coins -the DESO- which gives her the right to vote in the decisions at C-level. The traditional investor does not have these rights. The conventional investor can invest for a minimum of one year, while the Crypto investor invests for at least two years.

Both categories, the internal and external stakeholders and all investors, are subject to a strict complaint process before participating in the ROM ecosystem. The internal stakeholders are at management level and implement the outlined policy. And external stakeholders are; coin holders, advisers, project owners.

Please note that we have deliberately built-in safeguards that guarantee the integrity of our organization; these fall under the internal auditing committee of money transactions, money origins, assessment of the business plans, and screening of the ethical code and the category of all our customers.

Internal shareholder portfolio

When the submitted projects are completed, the shareholders can submit other projects to be included in the ROM ecosystem. They also get a lifetime reward with ROM. Not only by staking their own purchased coins but by participating in the ROM ecosystem with another project; this entitles them to share with the ROM profits. We give rewards in coins because this system, unlike the current traditional banking system, ROM makes it possible to reward entrepreneurs when they achieve a current state of productivity. A healthy ROM system cannot exist if corruption is embedded in the financial design. The people who perform must be adequately rewarded for their achievements. This makes the ROM economic structure balanced compared to the conventional banking system. The accountability and transparency management style ensure that all participants get a fair share of the profits for their input.


The two-year investment pools will be closed when the project cap is reached in the ROM ecosystem. From then on, only coin holders with smaller budgets can purchase ROM coins; both types of investors can invest simultaneously. The smaller budgets will be rewarded with staking rewards and airdrops. The market cap will only expand if more projects are submitted and approved to back the ROM coin.

Exchange

The complete Dapp will be coded in phases and then finished with a user interface and Web3 library in the subsequent stages. We deliberately started by launching our exchange and not other functionalities of the Dapp. We do this intending to uphold our governance of accountability and transparency policy. The test exchange gives the public and shareholders a glimpse of Roms' tech skills and the experience that all financial transactions can be followed. This, of course, is a test exchange, but in the later phases, the test exchange will be transferred to the original exchange after the smart contract has been audited. The real and more comprehensive exchange will allow all users to see the transaction history and coin allocations. For now, everyone can experience the transparency and ease of Roms' financial product.
